Aquasizer Underwater Treadmill TWO YEAR WARRANTY

Hot Tub Products is the Manufacturer of the Aquasizer Underwater Treadmill and warrants that it will be free from defects in material or workmanship that would cause it to be inoperable in normal working conditions. Any defects in materials or workmanship for two years from the date of purchase by original purchaser will be repaired or replaced at the option of Hot Tub Products LLC. This warranty provides 100% coverage on parts only.

EXCLUSIONS TO WARRANTY

- Aquasizer has been subjected to alteration, misuse or repairs on the treadmill by anyone other than our authorized representatives, unless express written approval is given.
- Damage caused by improper handling or during transportation from the dealer to purchaser.
- Any damage resulting from any misuse, abuse, negligence, acts of God, accident or alteration.
- Any damage due to excessive use or improper maintenance of chemicals in the water.
- The warranty covers the operational use of the treadmill but does not cover scratches, abrasions, or any defects to the finish of the material caused by normal use.
- Warranty is for two (2) years for personal use. Commercial use (hotels, gyms, etc.) is for one (1) year.

HOT TO OBTAIN WARRANTY SERVICE

First notify the Seller of the defective part or failure of the treadmill. **No returns will be accepted without a prior issued "Returned Goods Authorization".**

The warranty includes replacement and shipping of any defective part approved by Manufacturer but does not include labor. If the owner and/or seller is unable to perform repair they may return to it Manufacturer at their expense. The Manufacturer will repair the product and pay the cost of the return anywhere within the continental US. Any freight outside of the Continental US will be at the expense of owner.

FREIGHT DAMAGE: Any product damaged in freight will either be replaced or provided parts for repair which will be at the discretion of Manufacturer. Purchaser is required to provide photographs and a description of any damage along with the name of the carrier within two (2) business days of receipt of the product to both the Seller and the Manufacturer.

WARRANTY COVERAGE

Manufacturer will repair or replace at their discretion any defects, if upon inspection by Manufacturer, or any company designated by Manufacturer that it is determined to be covered by the warranty.

Manufacturer warranty begins from the date of delivery to original purchaser. Hot Tub Products shall in no event be liable for any amount more than the original purchased amount.

Implied Warranties: The only express warranties are set herein and any implied warranties, including the warranties of merchantability and fitness for a particular purchase, are limited in duration to that of the expressed warranties. This warranty does not cover consequential damage or incidental damage including damage to property or injury arising from the use or inability to use this product. Under no circumstances shall Manufacturer or any of its representatives be held liable for injury to any person or damage to any property however arising. Some states do not allow this exclusion or limitation of consequential of incidental damages, so the above limitation may not apply to you.
